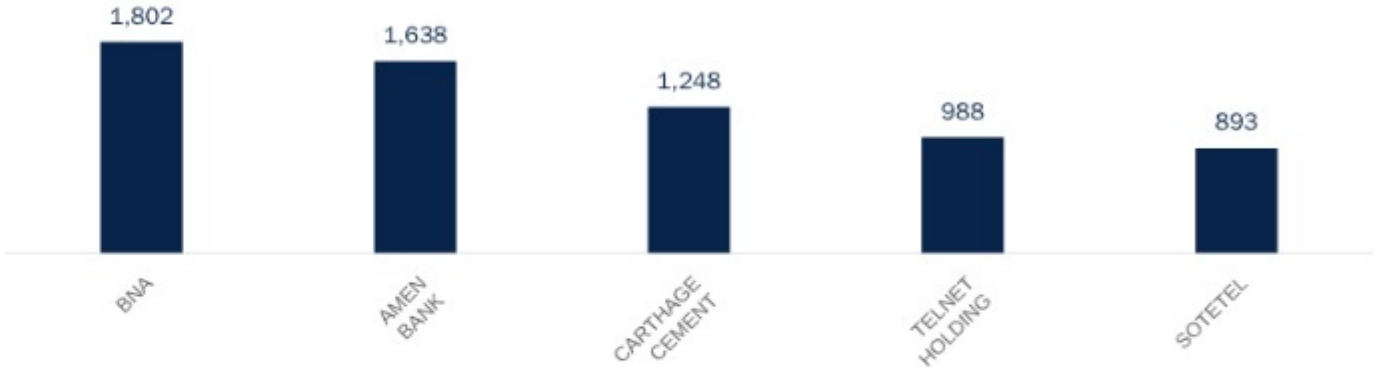

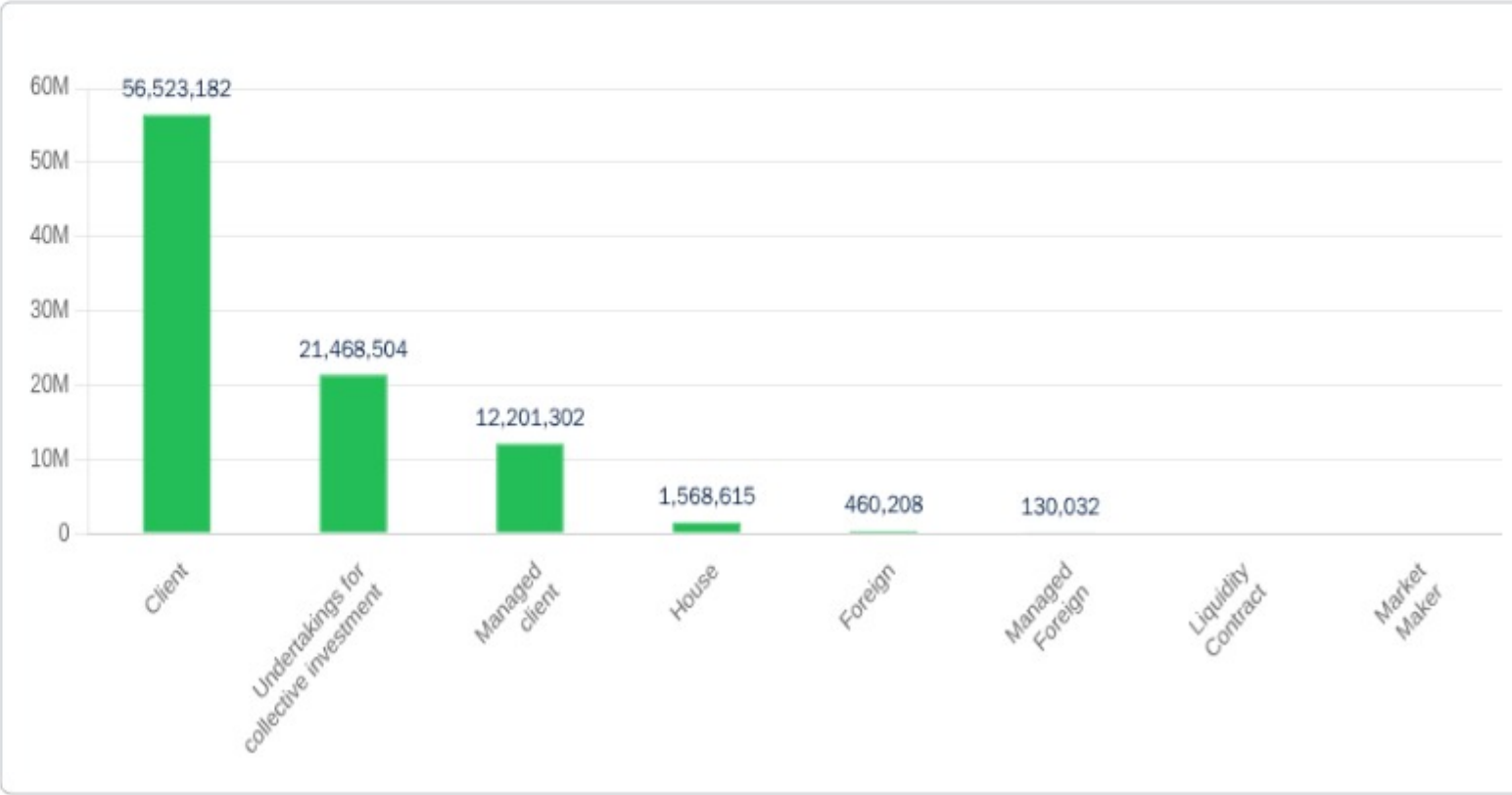

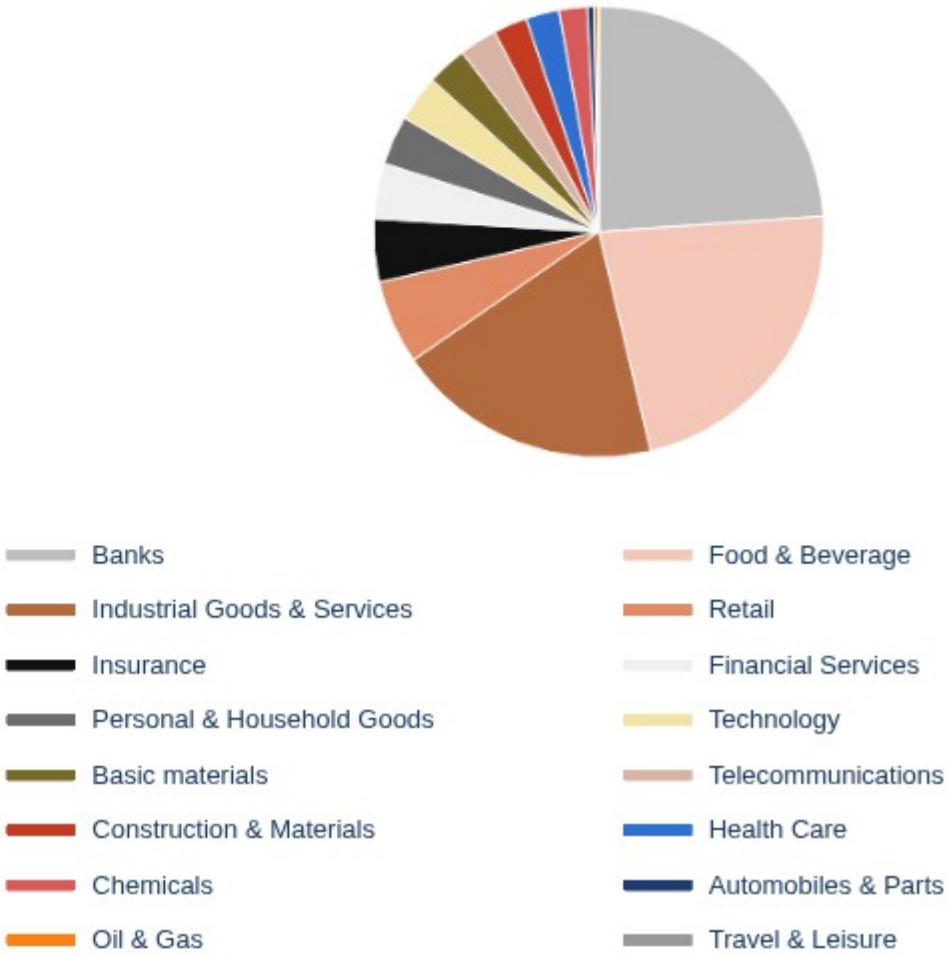

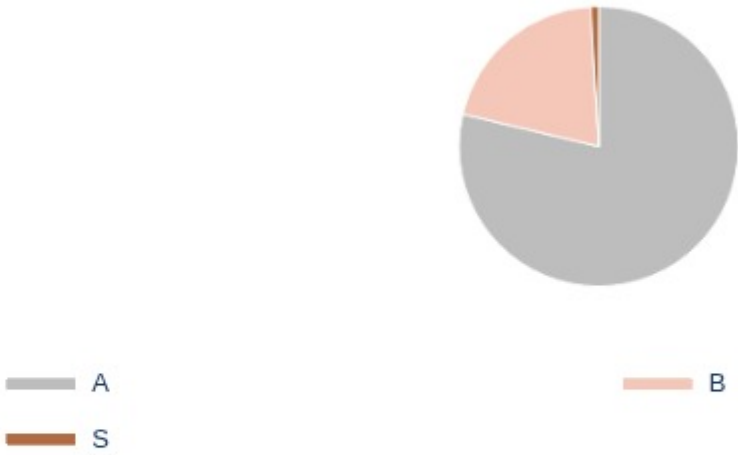
Capital Distribution by Sector

Répartition des Capitaux par Compartiment



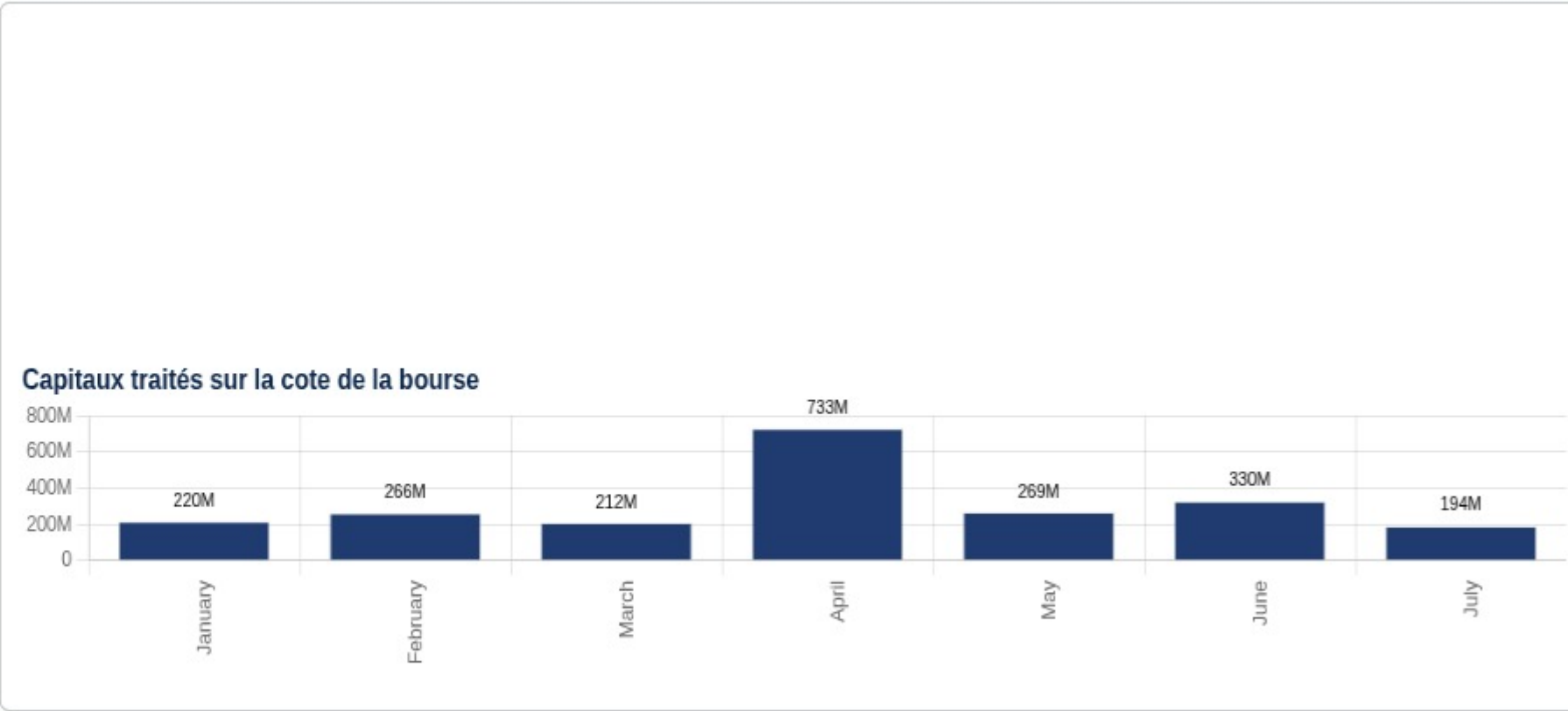

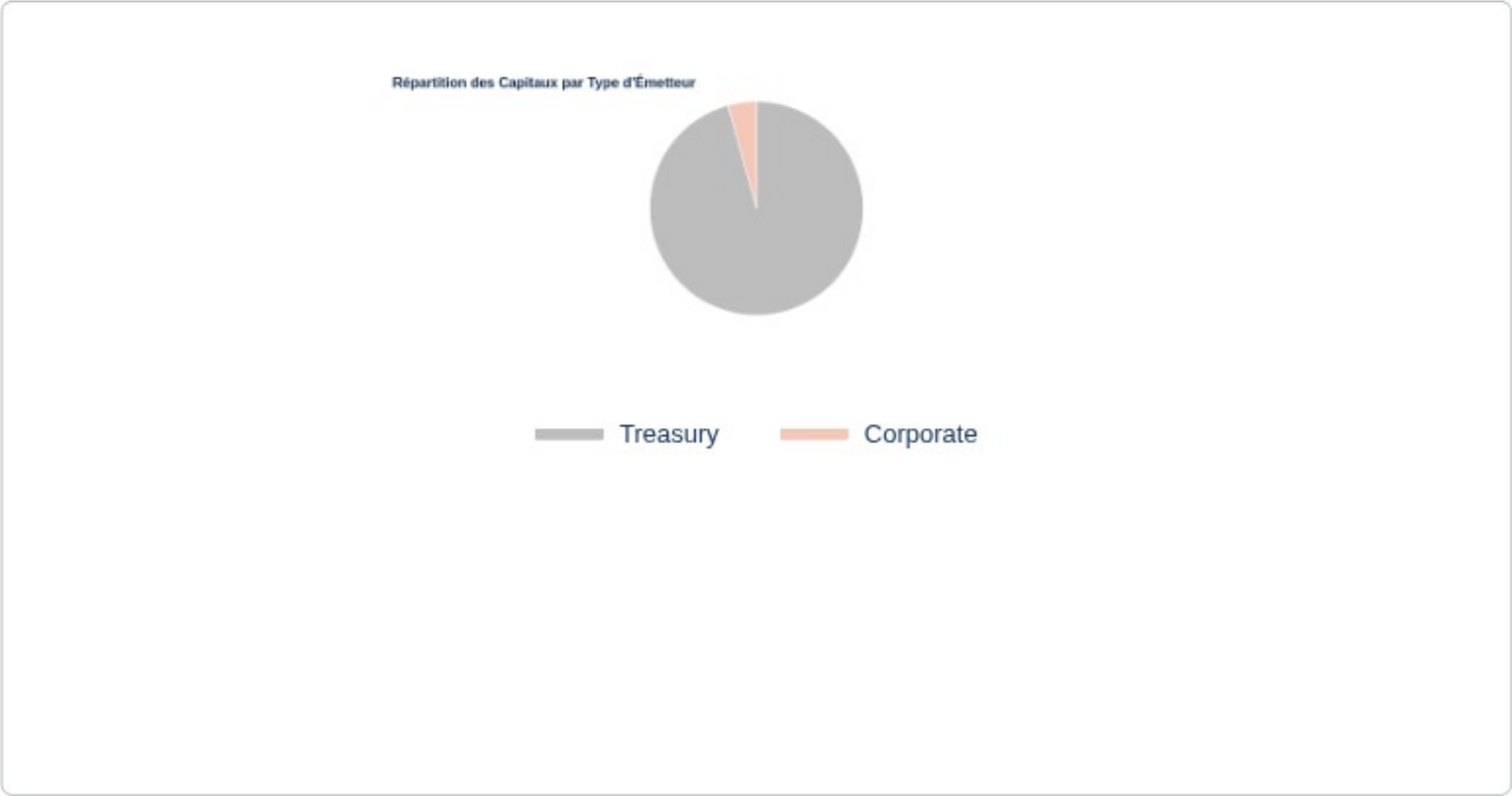
